Purpose

- To promote public awareness of Amateur radio and Mississippi's State Park system.
- To promote a spirit of friendship and goodwill within the ranks of Mississippi Amateur Radio Operators and Amateur Radio clubs.
- To encourage contact with other Amateur Radio Operators around the state, country, and world.
- To provide additional field operating experience for Mississippi's Amateur Radio Operators.

Overview

This is our 2nd Annual Mississippi State Parks on the Air. Last year we had over 1100 QSO's!

As of this writing, there are at least 133 reference entities in the POTA database. Not all of them are parks. Only those with "Park" in the name will be used for MSPOTA.

There are twenty-one (21) State Parks in Mississippi, and we need to have most, if not all, of those 21 state parks activated by as many amateur radio operators as possible on the day of the event. This will entail the efforts and cooperation of multiple Mississippi clubs.

Except where noted in this document, POTA rules will apply. See <https://pota.app/> for more details. All MSPOTA activators will operate as if they were activating a State Park for POTA. Co-activating is allowed. When activators mail their adi file to the certificate coordinator, please include the co-activators call signs, if applicable.

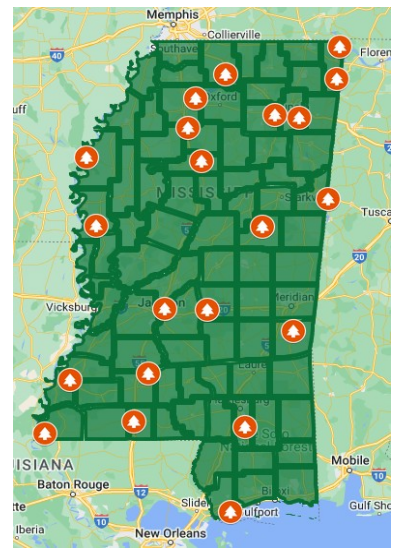
As in POTA the guidelines, all rules and regulations of the MS State Parks, will be followed. Fees need to be paid where they are required. If you use Pavilions then those need to be reserved and paid for.

- To activate most, if not all, the 21 state parks in Mississippi
- To get as many activators as possible to activate in the field

- To get as many contacts as possible during the event

MS State POTA Dates

The MS POTA event date: Saturday, 04/12/2025. 1300 UTC to 2259 UTC (8 am – 5:59 pm CDT). Ten hours.

Should a postponement be necessary, because of inclement weather, the makeup date will be 04/26/2025 1400 UTC to 2359 (8 am – 5:59 pm CST). Ten hours.

Modes and Bands

Modes of Operation: SSB, CW, FT8/4 and any other legal mode that POTA allows

Amateur Radio Bands: Any Ham Radio band can be used. Also, 2m and 70cm - VHF/UHF Simplex is acceptable.

Stations may be worked once on each band, mode, and by activator.

Activation conventions:

FT8/4:

Use the conventional CQ POTA ... mechanism on the TX6 line

Phone:

CQ Mississippi POTA <CALLSIGN> calling CQ or some variation thereof.

CW:

CQ CQ MS POTA ...

Usage of POTA spotting is recommended by anyone (including self-spotting, allowed by POTA rules).

MS POTA guidelines:

Jackson County ARA (<https://jcmsara.org>) and the Area 51 Radio Group (<https://www.facebook.com/groups/area51radiogroupms>) will be the Coordinators for this event.

Each Activator can use any combination of allowable modes anytime during the day. Self spotting to POTA is recommended at the beginning and when mode changing.

Each Activator at a Mississippi state park, during the event, should use their own callsign and use the US- designator that POTA uses. Please log all contacts, generate an adi file, and upload to the POTA website. This will entail that each Mississippi state park activator be a registered user of POTA.

Activators, in addition to uploading their adi files to POTA, will also mail those adi files to the certificate coordinator: ms.parksontheair@gmail.com, so that processing for certificates can be carried out. No Cabrillo files will be accepted. It does not matter how many adi files one activator has, they must send them all to the certificate coordinator. For instance, all wsjtx_log.adi files and other adi files that are generated from other logging software, if modes other than FT8/4 are used, should be sent.

HamRS (<https://hamrs.app>), will be the logging software of choice, for non FT8/4 modes, as it is simple, and is tailor made for POTA. Such is not the case with other logging software.

All activators, please use the following format when sending adi files to the certificate coordinator:
Subj: MS State Parks on the Air: US-xxxxxx

In the email please indicate the activator's callsign, or callsigns (in the case of co-activation). If there are multiple activators, then each of them will count for credit for the contact.

Include all adi files as attachments.

All adi files will conform to the format specified in the POTA documentation. Make sure that <my_sig> and <my_sig_info> are part of your adi file. Using HAMRS will make sure of that.

Rename all adi files to have your PARK number and Activator Callsign as well. For instance: US-2550_N5MES_2024_1.adi, or US-2550_N5MES_FT8_1.adi (or something similar).

Activators, please NOTE: All adi files that are generated by wsjt-x must include either FT8 or FT4 or wsjtx or something to indicated that the file was generated by wsjt-x. The reason for this, is that there is no good way to indicate the adi fields <my_sig> and <my_sig_info> in them. The certificate coordinator will take care of that.

Scoring:

There will be scoring for Hunters, and Activators.

Scoring for Activators:

Each band/mode/contact in your log, will score 1 point. With the exception of CW, which will count as 2 points.

There will be a special certificate for the Activator that:

1. Has the most QSO's,
2. or has the furthestest DX contact.

Scoring for Hunters:

Each band/mode/activator will score 1 point.

Modes are:

SSB
CW
FT4
FT8
JS8
PSK31
DATA

The Bands are:

160m, 80m, 40m, 30m, 20m, 17m, 15m, 12m, 10m, 6m, 2m, and 70cm (FM simplex)

Each CW mode contact will count double, as that is the most difficult.

Scoring Scenarios:

Scenario #1:

W5AAQ has a QSO with K5AHU in park US-2548 on 20m on SSB : 1 point
W5AAQ has a QSO with K5AHU in park US-2548 on 10m on SSB : 1 point
later in the day, W5AAQ has a QSO with N5AVU in park US-2548 on 20m on SSB : 1 point
W5AAQ has 3 points, 2 bands, 1 mode with 2 activators.

Scenario #2:

KA2AAB has a QSO with K9ACX in park US-2547 on 40m CW : 2 points
KA2AAB also has a QSO with K9ACX in park US-2547 on 20m CW: 2 points
KA2AAB also has a QSO with K9ACX in park US-2547 on 10m SSB: 1 point

KA2AAB also has a QSO with K9ACX in park US-2547 on 20m SSB : 1 point

KA2AAB also has a QSO with K9AGC in park US-2547 on 20m SSB : 1 point

KA2AAB now has 7 points. 3 bands 2 different modes, 2 different activators (it doesn't matter the same park)

Certificates

There will be certificates emailed to all contacts who are in any Mississippi parks adi file, (who have valid email addresses in QRZ). If the contact does not have a valid email address in QRZ, then no certificate will be mailed. It is up to the individual contact to make sure that their QRZ email address is up to date.

There will be a special certificate for hunting all activated Mississippi state parks, (and an invitation to come down to our fine state for a visit!)

Plaques:

There will be two special plaques, for Hunters:

1. For the hunter who contacts all the State Parks on the included list during the contest and has the highest total score.
2. For the hunter who has the highest total score.

There will be one special plaque, for Activators:

1. Most QSOs from any one activator. There will not be any limitation on how many parks that the activator will activate.
